IFM Fund's small grant mechanism is improved

 Support and facilitate independent forest monitors on consolidation/coordination meeting, training, monitoring activities and media promotion (FAO EU FLEGT & MFP)

 Until now, there was 24 small grants that have been distributed to IFMs at the local (FAO EU FLEGT & MFP)

 IFM Fund using the SoP Grant Making as a guideline (proposal form, reporting, panel proposal, etc)

Short-term financing strategies

Improving the capacity of IFM-Fund to raise and managing funds:

- The LOA of FAO-EU FLEGT project phase II has signed at 17 June 2020
- The LOA of Palladium MFP 4 has signed at 13 Nov 2020 to develop of SVLK – implementation monitoring scheme at jurisdictional level (KPHP) by independent monitoring organization (IFM)
- Identification potential donors and program collaboration in monitoring

Strengthening IFM Fund Institution

- Capacity building for IFM Fund Staff
- External audit for project and IFM Fund Institution
- Develop and implementing the Resources Mobilization Strategy of IFM Fund
- Conduct portfolio review of IFM Fund

IFMs fully engaged on SVLK implementation and has capacity to carry out monitoring

- Participate in serial policy dialogues: JEM IND-EU, Public consultation on revision Minister Regulation on SVLK and others relevant workshop
- Conduct workshop on Strengthening the Role of Independent Monitors in the Implementation of SVLK and FLEGT-VPA

Medium/Long-term financing strategies

- Communication with BPDLH and MoEF to develop the sustainable financing for IFMs
- Communication with LVLK forum related the V-Legal fee as potential financing for IFM with clear mechanism in legal document

Medium- and Long-Term Financing of Independent Forest Monitoring via IFM Fund

(sinking fund with a reserve of up to 3 years of annual cost estimate)

Estimate Annual Cost to support IFM

| Type of cost | % | Minimum annual cost USD |
|------------------------------------|-----|-------------------------------|
| Monitoring missions | 50 | *700,000 |
| Training of investigators/monitors | 30 | 420,000 |
| Administration and outreach | 20 | 180,000 |
| Total | 100 | 1,400,000 |

^{*:} based on the monitoring of a minimum of 5% of the total operational business units a year, across 17 key provinces and 3 field investigations per unit.

Possible Funding Sources

- Percentage (12.5 ?) of V-Legal/FLEGT licensing fees collected (2019: 3,086,664 USD) and credited to IFMF account once or twice/year (estimate of 385,000 USD/year)
- 2. MoEF contribution through Annual State Budget Allocation (Anggaran Pendapatan dan Belanja Negara APBN), as per SVLK regulation referring to assurance of funding from State or Regional budgets (only for capacity building to ensure IFM independence).
- 3. Existing or new Trust Funds
 - Environmental Fund Management Agency (Badan Pengelola Dana Lingkungan Hidup – BPDLH)
 - A dedicated IFM Trust Fund (based on MFP-4 Study)

Possible JIC action points

- MoEF could support to issue circular for payment of % of Licensing Fees from CABs
- MoEF could contribution to IFMs capacity building cost in next budget plan submitted to APBN
- 3. EUD and MoEF could help to mobilize support for IFM Fund grant application to BPDLH (MFP4, EFI and FAO to help provide evidence of the contribution of IFM to BPDLH objectives)
