# **SUMMARY**

#### Three Years of IFM FUND

THIS PROGRESS REPORT is prepared for monitoring and evaluation of IFM Fund work programme's 2017-2020 implementation and achievement. As commonly known, IFM Fund was established to meet the following objectives: (a) facilitate funding support for Forestry Independent Monitoring activities; (b) facilitate activities that support Forestry Independent Monitoring quality; and (c) improve Forest Government quality through Forestry Independent Monitoring activities.

This report framework is built upon description of progress in work programme, including implementation of collaborative projects with IFM Fund partners, performance of IFM Fund small grant funding investment & support, financial position and status, asset management and publication and communication media through which IFM Fund communicates with public.

"Strengthening and operationalise a fund management institutions for independent monitors so that they can play active roles in strengthening Timber Legality Assurance and forest governance in Indonesia

This report elaborates the implementation of projects that IFM Fund has managed during 2017-2020. Since the beginning of their initiations up to the mid-2017, IFM Fund has obtained funding support from MFP-3. Next, during August 2018-March 2020, IFM Fund forged a cooperation with FAO-EU FLEGT Programme for a 15-month project (phase 1).

Apart from that, this report provides information on the performance of IFM Fund's investment and funding support channelled to support independent monitors' works in Indonesia. IFM Fund's investment is implemented through small grants ranging between USD5,000 and USD10,000 provided to individuals, organisations and community groups. The monitoring activities by individuals, organisations or community groups include not only activities directly related to the Timber Legality Assurance System (TLAS), but also forestry sector monitoring in a wider sense.

In general, IFM Fund's investment and grant portfolio suggests a direct link between grants provided to partners and its three objectives. IFM Fund-supported partners and activities has directly contributed to capacity building strengthening and facilitation, forestry independent

monitoring and forest product distribution, and exchange of information that supports forestry independent monitoring in Indonesia. More specifically, IFM Fund grant portfolio has produced outputs, i.e., civil society involvement and capacity in forestry independent monitoring within the framework of TLAS and FLEGT implementation, its developed and tested small grant mechanism, and its strengthened organisational structure, role and resources.

IFM Fund has gone through project audit processes, including MFP-3 and FAO-EU FLEGT Phase 1 Project Audits. In general, the audits resulted in **unqualified opinions** in all matters that are material, financial position, project activity report, in accordance with Generally Accepted Accounting Principles (GAAP) in Indonesia. In addition, IFM Fund in its organisational capacity has audited 2017-2019 financial reports for the first time, which started in the beginning of November 2020, resulting in **unqualified opinion**.

#### I. BACKGROUND

Timber Legality Assurance System (TLAS) is an initiative aiming to ensure that timbers and timber products can be verified to guarantee legal and sustainable sources. TLAS becomes plays the pivotal role in Indonesia-European Union partnership agreement as it can be used as TLAS. Under this system, all products that the agreement covers are required to have legal licence so as to enter EU market.

Since the first time this policy was applied, independent monitors have actively got involved as part of civil society contribution to forest governance improvement in Indonesia. They realised the intense public demands that TLAS credibility in Indonesia be constantly maintained. This definitely requires independent monitors' capacity in effective monitoring to contribute a constructive input to the system implementation.

Funding guarantee for independent is already provided under Minister of Environment and Forestry Regulation No. 30/2016 in conjunction with Minister of Environment and Forestry Regulation No. 21/2020 where §36.1 provides that the Minister and local governments may provide fund to independent monitors to support TLAS monitoring activities, and §36.2 provides that the fund under paragraph 1 shall be allocated following the State financial use and reporting rule.

The needs for establishing a monitoring fund management organisation also become one of the achievements that should be reached under the FLEGT-VPA action plan agreement, which were reconfirmed in Joint Expert Meeting (JEM) on 2 March 2017 mentioning the importance of establishing an organisation to support independent monitoring works through a sustainable funding mechanism (Agreement 1.5).

Independent monitors then discussed this through series of meetings attended by externals (donors, researchers and Ministry of Environment and Forestry) as well as other meetings involving only independent monitors. On 27 April 2017 in Bogor, there has been established Yayasan Pemantau Independen Kehutanan Indonesia (Y-PIKI Foundation) before Notary Public Ellyza, S.H., M.Kn. based on Notarial Deed No. 03/2017. The foundation is then known as Independent Forest Monitoring (IFM) Fund.

The foundation was established to:

- a) facilitate funding support for Forestry Independent Monitors;
- b) facilitate activities that support the quality of Forestry Independent Monitor; and
- c) improve Forestry Governance quality through Forestry Independent Monitor activities.

To achieve the above objectives, the foundation carries out the following activities.

- **1.** To facilitate funding support for forestry monitoring activities, the following activities will be carried out.
  - **a.** Raise fund from public and domestic and international private sources that are not binding to and do not go against the foundation's basic principles.
  - **b.** Provide grants to Civil Society Organisations (CSOs) or NGOs that carry out forestry independent monitoring.
- **2.** Facilitate activities that support the quality of forestry independent monitors in delivering monitoring method trainings.
- **3.** To improve the quality of Forestry Governance through independent monitoring activities, the following activities will be carried out.
  - **a.** Advocation for various stakeholders concerning the importance of forestry independent monitoring output for governance improvement.
  - **b.** Facilitating publication and disseminating monitoring outputs and forestry independent monitor organisation profile.

#### II. FOUNDATION STRUCTURE & MEMBERS OF EXECUTIVE BOARD

Based on the foundation's deed of establishment, IFM Fund structure includes Advisory Board, Supervisory Board and Executive Board. Executive Board is an organisational organ that includes Chairman, Secretary and Treasurer and is responsible for running the organisation within a five-year period. It can be assisted by Director and executive staff to implement its mandate.

In October 2017, one of YPIKI founders, Arbi Valentinus (Chairman of Supervisory Board) deceased. The remaining founders are now eight people.

In the context of work programme management, Executive Board forms its organisational tool, i.e., Executive, to assist in implementing the work programme and run YPIKI Secretariat operation. To date, there has been changes of staff in IFM Fund Secretariat. Currently the foundation has five people to man the Secretariat's executive positions.




Figure 1. IFM Fund Secretariat Structure and Executives

#### **Executive Board Meeting**

Executive Board is the foundation's organ responsible for its management performance and interests. To execute the mandate, the Executive Board has held a series of meetings, including scheduled meetings that have been held twice (July 2019 and November 2020) and irregular meeting due to the quite intense interaction between board members. The agendas concern with the organisational development, formation of organisational organs (executive), fund raising, and response to strategic issues.

#### III. COOPERATION AND FUNDING SUPPORT

Projects that IFM Fund has managed during 2017-2020 have been directed to facilitate its missions and objectives in supporting independent monitoring. When initiated for the first time in 2017, IFM Fund was supported through MFP-3 funding. The 7-month funding (June-December 2017) was directed to [1] establishment and operation of trust fund functioning to support TLAS monitoring activities and improve independent monitor's governance; [2] management of resources for independent monitors; [3] pilot grant fund distribution system; and [4] prepare programme and strategic plan for independent monitors as the vital actor in implementing TLAS in Indonesia.

Later on, IFM Fund secured funding support in the form of bridging fund from European Forum Institute in June-July 2018, which was a transitional period before it obtained FAO-EU FLEGT Programme's funding support. In August 2018-March 2020, IFM Fund developed a cooperation with the FAO-EU FLEGT Programme to cover a 15-month period (phase 1).

#The FAO-EU FLEGT Programme has approved the support for IFM Fund to allow the foundation to continue playing its role in facilitating independent monitors and their network. This project is expected to be able to bridge independent monitor needs when carrying out monitoring and capacity building. IFM Fund also simultaneously makes effort to encourage a continuous funding mechanism for independent monitors. The project aims to strengthen and facilitate capacity building, fund raising and distribution mechanism, and information sharing to support forestry independent monitors in Indonesia (**Table 1**).

In June 2020, FAO-EU FLEGT Programme agreed to keep up the commitment to supporting IFM Fund in facilitating Independent Monitors' activities. Aiming at making more efforts to ensure continuous fund for independent monitors while also building their capacity in monitoring forestry sector in Indonesia, this 2<sup>nd</sup> phase cooperation project will take 12 months to complete (up to May 2021).

In addition, IFM Fund also has established communication with MFP-4 to secure funding support for developing local-based TLAS implementation monitoring scheme, i.e., Forest Management Unit (FMU), and area administration by independent monitors. Currently this has stepped into the phase of cooperation agreement finalisation.

#### IV. PROJECT MANAGEMENT

Implementation of projects that IFM Fund has managed from 2017 to 2020 was directed to achieve the foundation's objectives, namely facilitate funding support for forestry independent monitoring activities, particularly in implementing TLAS, facilitating support for forestry independent monitoring quality, and improving forestry governance quality through forestry independent monitoring activities.

#### 4.1 SUMMARY OF MFP-3 COOPERATION PROJECT IMPLEMENTATION

All activities proposed aim at keeping TLAS credible and accountable through regular monitoring system. These activities mainly target civil society organisations and local community/indigenous peoples' groups that are expected to actively participate in monitoring concerning the system implementation. The activities also target the Government, donors and other stakeholders that may potentially provide funding support to independent monitors. See **Annex 1** for June-December 2017 implementation of the cooperation project with MFP-3.

In general, the activities' objective is to strengthen and operationalise a trust fund-managing organisation for independent monitors to allow them to play active roles in Timber Legality Assurance and forest governance improvement in Indonesia. See below the specific objectives to meet within 7 months of the proposed project's implementation.

- **a.** Establish the fund-managing organisational structure and make available mechanism of grant fund distribution to forest governance monitoring and improvement activities.
- **b.** Develop strategy for cooperation between the fund-managing organisation and independent monitors in strengthening forest monitoring system in Indonesia.
- **c.** Raise resources with the Government, donors and other stakeholders that may potentially provide funding support to independent monitors.
- **d.** Pilot grant fund distribution system to support independent monitors' activities.

#### 4.2 SUMMARY OF FAO EU-FLEGT COOPERATION PROJECT (PHASE 1) IMPLEMENTATION

In early August 2018, FAO-EU FLEGT Programme has approved granting support to IFM Fund to keep up its role in facilitating independent monitors and their network. This project is expected to be able to bridge independent monitors' needs for monitoring and capacity building. In a parallel manner, a mechanism for continuous funding for independent monitors is also encouraged. See **Annex 2** for detail on the implementation of cooperation project with FAO-EU FLEGT Programme (Phase 1).

This project aims at capacity building, fund raising and distribution mechanism, and information sharing to support forestry independent monitors in Indonesia. This project output includes: (a) civil society completely participates in and has capacity for independent forest monitoring of TLAS and FLEGT implementation; (b) establishment and implementation of IFM Fund's small grant mechanism; (c) IFM Fund's strengthened organisational structure, role and source of fund; and (d) established monitoring and evaluation framework and project visibility.

#### V. IFM FUND SMALL GRANT PORTFOLIO<sup>1</sup>

This section provides information on IFM Fund's investment performance and funding support in accordance with its establishment objective, i.e., to facilitate funding support for forestry independent monitoring activities, particularly in TLAS implementation, facilitate support for forestry independent monitoring quality, and improve forestry governance quality through forestry independent monitoring activities.

#### V.1 SMALL GRANT GROWTH AND VARIETY

With MFP3 support during the 2017-2018 period and FAO-EU FLEGT Programme Phase 1 during 2018-2019 period, IFM Fund has invested in forestry independent monitoring through 21 small grants. This portfolio started in the 2nd semester of 2017 where IFM Fund provided 6 small grants (**Table 4**) and then 1 grant in 2018, 7 small grants in the 1<sup>st</sup> semester of 2019 and another 8 in the 2<sup>nd</sup> semester of 2019 (1 grant for media) (Table 5).



Concerning the contract amount, the smallest is for Genesis Bengkulu and the largest is for Kaoem Telapak and Forestry Independent Monitor Network (JPIK). By the types of activities supported, out of 21 small grants in total (2017-2019), 13 totalling to IDR648,826,000 was directly addressed to forestry independent monitoring field activities and publication of the results.

above indicates that there are 3 small grants totalling to IDR374,093,710 for consolidation, coordination, workshop and network strengthening, as well as 4 small grants totalling to IDR315,159,459 for forestry independent monitoring training and another of IDR60 million for making film as part of securing the support for IFM Fund.

#### V.2 SMALL GRANT PERFORMANCE AND OUTPUT

#### **Forestry Independent Monitoring**

From 2017 to 2018, IFM Fund has provided 13 small grants that directly relate to its core business, i.e., forestry independent monitoring field activities. A wide range of such activities

are carried out throughout the country by forestry independent monitors in their capacity as both organisations and individuals.

In general, the forestry independent monitoring activities have successfully managed to find and expose a variety of problems and regulation violation by companies that hold forestry concession permits. These problems and violations include violation of forestry administration and governance including violation against TLAS provisions, illegal timber trade and processing, unconformity with work plan, failure in protecting concessions, and overlapping land tenures and managements.

Not only does IFM Fund small grant portfolio focus on the companies holding the concessions above, it also covers forestry independent monitoring that particularly targets illegal logging and trade activities. In this focus, forestry independent monitoring in general finds a wide range of modes and activities of illegal logging, timber laundering, timber shipping and trade without complete documents and permits, and TLAS violation.

#### **Forestry Independent Monitoring Consolidation and Coordination**

Consolidation and Coordination between independent monitors is vital and should be continuously carried out because this activity is the backbone to forestry independent monitoring functions, hence the main constituent of IFM Fund.

Consolidated forestry independent monitors are mainly characterised by their built capacity as well as effective and productive forestry independent monitoring activities. This way, the independent monitors' performance also directly reflects the performance of IFM Fund's grant portfolio.

A wide range of impacts on legal enforcement and strengthening of mechanisms and sanctions relating to permit issuance and legal standards jointly contribute to the improvement of performance and forestry governance. Therefore, it is important to maintain this forestry independent monitoring momentum and intensity so that the governance changes and improvement becomes permanent and continuous. This also entails maintaining and even strengthening IFM Fund grant portfolio that already plays a pivotal role in independent the wide-impact monitoring activities' capacity building and implementation.

#### **Forestry Independent Monitor Capacity Building**

Small grant specifically concerns with capacity building for forestry independent monitors. This activity is basically complementary to various capacity building activities in forestry independent monitoring by many organisations backed by different sources of fund support. One of the IFM Fund's small grant portfolio features is capacity building for woman group as part of the forestry independent monitors in East Java.

#### IFM Fund Media, Communication and Organisational Strengthening

There are small grants in IFM Fund portfolio that are concerned with the organisation's media, communication and organisation strengthening, namely making of film titled "Penggalangan Dukungan untuk Memperkuat Aktivitas Pemantau Independen" (Raising support to Strengthen Independent Monitors' Activities). It is meant to serve as a public communication material that can expectedly become an important role in IFM Fund's efforts to secure public support for forestry independent monitoring in general and specifically the organisation per se.

#### V.3 SMALL GRANT FUND SOURCE OPPROTUNITIES<sup>2</sup>

There are two Minister of Environmental and Forestry regulations that govern the mechanism of funding for independent monitors, namely Regulation No. 21/2020 (revised version of Regulation No. 30/2016) and Director General of Sustainable Production Forest Management Regulation No. 15/2016 in conjunction with Director General of Sustainable Production Forest Management Regulation No. 14/2016.

§36 regulates the following.

- The Ministry and local governments may fund independent monitors to support TLAS monitoring activities.
- **2.** The funding under paragraph (1) above shall be carried out subject to the State finance use and reporting rules.

The currently absence of further regulations covering monitoring work funding mechanism poses this further question: in case of unclear source of funding, will independent monitors be able to optimally perform monitoring works? The answer is certainly not, because of the limited extent of monitoring, moreover if compared to the condition where clear sources of funding is available.

The Government can facilitate fundraising efforts to support TLAS monitoring activities, including by issuing legal products that regulate the mechanism of allocation of certification fund secured from Assessment Body (LP) and Independent Verification (VI) to support independent monitoring. Based on stakeholder meetings thus far, Forum of Timber Legality

Verification Bodies (LVLK) has no objection to and supports this plan, provided that the funding mechanism for independent monitors is built through applicable regulations, accountable, credible, transparent and appropriately implementable.

Another funding opportunity that should be seized is cooperation with Environmental Fund-Managing Body (BPDLH) which performs its functions based on the mandate from (1) the funders and (2) owners of assets, services or projects concerned with the fund source. Funding opportunity for independent monitor regarding TLAS implementation is possible if space is provided to BPDHL by the stakeholders who give the mandate.

Another possible source of fund to IFM Fund is public donation. This alternative should be explored and developed based on learnings related to the increased public attention to forestry and environmental issues, as well as the desire to be a part of and give donation to efforts to address the issues. Progress has also been found in efforts to raise public donations by organisation operating in the same issues as well as others. Challenges have been found in searching for overlapping interests, activity ideas, and indicators of success that meet the expectation of the community groups.

Other than the alternative sources of fund above, what has become source of fund to IFM Fund is fund supports from donors such as MFP and FAO-EU FLEGT Programme. Raising funds from these donors is ultimately necessary taking into account the developed trust, excellent fund management performance, and programme suitability between IFM Fund and the donors.

#### VI. FINANCE

In documenting its financial activities, IFM Fund uses cash basis method modified with accrual basis system, where costs documentations are recognised upon payment while revenue documentations are upon receipt. IFM Fund financial statement employs a simple format with adequate explanations without violating the Generally Accepted Accounting Principles (GAAP) in Indonesia

#### **Financial Report Audit**

IFM Fund has gone through project audit processes, including MFP-3 Project Audit and FAO-EU FLEGT Phase 1 Project Audit. In general, the audits resulted in **UNQUALIFIED OPINIONS** in all matters that are material, financial position, project activity report, in accordance with the GAAP in Indonesia.

To maintain its credibility and fund management accountability in its secretariat, IFM Fund audits 2017-2019 financial statements (organisational finance audit) which started from November 2020. Same as the project report audits, in general this audit also has resulted in **UNQUALIFIED OPINIONS (Annex 3).** 

#### **Financial Statement Position**

Financial statements include three main report, i.e., consolidated balance sheet, Report of Activity & Changes in Assets, and Cashflow Statement. The three reports presented the position of all properties that had been owned by IFM Fund per 31 December 2019 (). As for the 2020 financial statement, currently it is still in consolidation process for re-reported in early 2021.

#### IX. RECOMMENDATION & FOLLOW UP STEPS

#### **Portfolio Strengthening and Diversification**

IFM Fund needs to expand and strengthen its portfolio in providing small grants to forestry independent monitors including individuals, civil society organisation, indigenous peoples and local community, as well as network organisations and forestry independent monitors' alliance throughout the country.

In addition, the organisation should seriously develop focus diversity in forestry independent monitoring activities. In this matter, the scope of IFM Fund's small grant also will expand to other sectors and aspects within the corridor of its vision and missions concerning forestry governance, e.g., aspect of policy weakness and corruption in the process of issuing permits, including concessions and timber legality permits, forestry business investment and financing flow, and social forestry as one of the potential focuses when relating to the legality of the legality of supply chain and timber trade and its governance.

Concerning the current development of regulations and policies as well as the importance of the guarantee for monitoring continuity including the guarantee for independent monitors' safety and security and access to data and information for monitoring, IFM Fund sees the importance of independent monitoring network to forge an alliance with organisation operating in/focusing on legal and human rights issues. It is important that IFM Fund cover these efforts in the future.

#### Strengthening sources of fund

IFM Fund strategy to access timber legality administration fee should be kept up and fruitful. Also, it appears that continuous funding basis should be explored from the State's forestry, environmental, industry and trade budgets. Blind trust should be established with private sectors, where the fund may be sourced from, for example, chamber of commerce and company association.

Another funding opportunities that should be continued is forging cooperation with Environmental Fund-Managing Body (BPDLH) which performs its functions based on the mandate from (1) the funders and (2) owners of assets, services or projects concerned with the fund source. Funding opportunity for independent monitor regarding TLAS implementation is possible if space is provided to BPDHL by the stakeholders who give the mandate. The key is the relevance of timber legality monitoring to the Sustainable Forest Management (SFM) in supporting REDD+.

In addition, given the permanent and continuous functions of and needs for forestry independent monitoring while donors' funding support is basically ad hoc and predictably keeps reducing in scale along with the increased status of Indonesia into a medium income country, IFM Fund should indeed become part of the national forest management system with the Government and public's material support for its continuity and development.
